Get ready as our region will be hosting the upcoming zonal forum in January 2011. I hope that it is held in an area that would benefit from the forum being held there. *I am requesting reimbursement for \$15 -tolls, \$64.86 -gas totaling \$79.86 for travel to the zonal forum. I have provided the treasurer with receipts. In world news In Times of Illness (revised), as well as the IP's money matters, and Funding NA services; were made available to the fellowship in July. I would like to take this time to let all members know that the delegate team is here to assist your areas with the APT and/or other items that you may need assistance with. Keep in mind that the delegate team sometimes has hectic schedules so make sure if our assistance is needed that you allow ample time to work with the team's schedule. Next Region will be my final as Regional Delegate. Etta, as the RDA will be an automatic nominee but keep in mind that the floor is open for nominations and as per regional policy I am (and have been) notifying this body that my term will be open in October.

- 9. Our Special Events committee has planned an End of Summer Picnic for September 11, 2010 in McIntire Park, Shelter 2, in Charlottesville. I brought some flyers.
- 10. The next Piedmont Area Service Committee meeting is scheduled for Sunday, August 29, 2010 at 4 p.m. at the Wesley Foundation. We have moved the meeting from the usual first Sunday because of the Labor Day holiday.
