Vice Chair Report	<p>Good morning,  Yesterday I had the pleasure to emcee the first day of the October two-day event. The food for Saturday's event cost \$125.75. Other than that, I can't think of anything further to report.</p>

Treasurer Report	<p>All the bills that I know of up to today are paid. We had a balance of \$14,693.83 at the 169th RSC. Since then we have deposited \$1462.96 (\$80.00 was returned funds from the Summer Institute). I have also added back in to the account \$328.06 that came from checks that were written but not used. We have had debits totaling \$915.23 to give us a current balance of \$15,569.62. Check 1167 is still out. I paid Primus and PCMS since the bank statement was issued so our actual balance doesn't match the bank statement associated with this report. Our current balance is actually \$14,797.09  Our YTD (2014) expenses have been \$13,646.97 and our YTD income has been \$13,677.71.  The one missing check was for \$300 and was sent to NAWS; or it was supposed to have been sent to NAWS. That check was written back in February. I will probably just add it back in at the next RSC.  Our prudent reserve as determined by the formula approved by the RCMs is \$15,277.00. If we subtract this from our current actual balance the difference is \$-479.91. We wrapped up the day with a power point presentation reviewing the decision making process at the WSC, and comparing the tally at our GSR Assembly, with each item's outcome at the World Service Conference. We thank all who took the time to attend and participate</p>

	<p>As per our policy Kim and I will be submitting a motion to approve costs associated with attending the Autonomy Zonal Forum January 31, 2015 hosted by the Chesapeake and Potomac Region. This motion can only estimate the costs since the specific location has yet to be announced. Given a likely location of somewhere in northern Virginia we estimate the room cost to be slightly higher than normal (\$125 for each us), but considering what will almost certainly be a less than average travel time we estimate the total per diem to be a little less (just \$35 for each of us). In addition we will each be requesting the customary \$40 gas advance.</p> <p>At our August RSC I relayed a request that the Autonomy Zonal Forum be permitted to utilize the customary Saturday morning "regional slot" at the 33rd AVCNA on January 10th in Lynchburg. The convention Program Subcommittee approved the request last week for an AZF presentation entitled "The Autonomy Zonal Forum (What We Are)". - Every delegate team is being asked for input on two items within 90 days:
  - A Guide to World Services in NA: Every conference cycle NAWS revises GWSNA to reflect new dates and other standard changes from cycle to cycle. This draft also reflects the changes made as a result of conference discussions and decisions that culminated in the passing of Proposal BC. It is out for a 90-day delegate review. Changes made as a result of Proposal BC are marked blue in the draft to make review easier. A final version will be distributed after all delegate input is incorporated.
  - WSC 2014 Draft Record: This is the complete draft conference record. Delegates are asked to let NAWS know within 90 days if we see something that needs changing. A final version of the record will be distributed before WSC 2016 for approval at the conference.

September 26-28 the Multi Zonal Service Symposium was held in Topeka, Kansas and I have been told it was a HUGE success. There were 236 registrations from 44 regions and there were 3 countries skyped in. They have made their workshop archive available online at <http://www.mzssna.org/> . They've included presentation files and streaming audio for all the events that were recorded. There is talk of a MZSSNA 2 and, though Eddie and I weren't able to attend this first MZSSNA, I really hope that CAR-NA can have representation at the next one.

We will work to satisfy this request by the next Regional Conference</p> <p>Bullet 5 – The next NAWS H&amp;I/PR webinar will be held November 12th, 2014 at 6:00 p.m. eastern standard time.
