	It came to my attention last fall that the email addresses for the chairs of our subcommittees, RD Team, and executive committee were also copied to another email address and, from time to time, some of the email sent to those recipients were read by a third party. The eighth concept in NA's Twelve Concepts for NA Service states, "Our service structure depends on the integrity and effectiveness of our communications." Few will doubt the seriousness of opening another person's US postal mail and I see no difference in opening someone else's email. I met with the chair of the PR Subcommittee, Etta, and brought these concerns to her. She devised a plan of action and took the necessary steps to rectify the problem during the subcommittee meeting. I had an addict bring a television news human-interest news story to my attention last month wherein the reporter interviewed the pastor of a church whose mission included providing space for NA meetings and an addict who spoke of the importance of NA in his recovery. The story was up-beat, and portrayed recovery in NA and the church's mission in a positive light. However, this story sparked a dilemma regarding NA's 12 Traditions within the home groups who held meeting in the church and other members in that area. As chair of our region and as a member of NA I can do little more than provide my personal experience, strength, and hope in a situation such as this. I gladly watched the video, which is currently off-line, and discussed the issues with the addict. My personal feeling is that in the years to come, we will continue to see stories in all the various forms of media about NA and positive publicity such as this only serves to point those in need to where they can find help. Quite a few GSRs began sending in their room requests and I have responded to each of them. I have informed them that they are "on the list", which will remain open, until one month before the GSR Assembly. At that time, pursuant to our G & RO, I will send notifications to them as to whether we

The workshop for Quadrant 4 will be Saturday March 5th from 11-4 at Poquoson Baptist Church, 283 Wythe Creek Road, Poquoson VA. The workshop for Quadrant 3 will be Saturday March 12th from 11-4 at St. Andrew Presbyterian Church, 21206 Timberlake Road, Lynchburg VA. The workshop for Quadrant 1 will be Saturday March 19th from 11:30 – 4:30 at Hatcher Memorial Baptist Church, 2300 Dumbarton Ave, Richmond VA. The workshop for Quadrant 2 will be Saturday April 2th from 11-4 at Verona United Methodist Church, 406 Lee Highway, Verona VA. I will be submitting a motion today for our Treasurer to write four separate checks (each in the amount of \$75 to cover rent) made out to each of the aforementioned facilities. 	MARLCNA: February 5-7 I attended the Mid Atlantic Regional Learning

Convenference of Narcotics Anonymous in Lancaster, PA. Kim was unable to attend due to a traumatic injury she sustained just prior to the event. As it always does during a conference year MARLCNA serves as a multi-regional CAR Workshop facilitated by members of the World Board with NAWS staff participation. Friday night consisted of the annual NAWS Update and Saturday focused on the various components and motions contained in the CAR and CAT. The two WB members in attendance were WB Chair Franney J., and WB Vice Chair Arne H. Those familiar with the structure of the CAR are aware that the World Board always includes a "WB Rationale" (for any WB Motion) or a "WB Response" to every Regional motion submitted. The real value in attending this event is the opportunity to gain further insight into the "pros and cons" by hearing directly from members of the WB, or in many cases (as with Motions 13 and 14) the Delegates who submitted some of the Regional motions contained in the CAR or CAT.

- FUNDS BEING RETURNED: As Kim was unable to attend MARLCNA I will be returning \$308 today from the funds I received at the October RSC (\$198 for her two nights lodging, \$70 for her two days per diem, and \$40 for her gas advance). In addition, I have three gas receipts for myself from MARLCNA totaling \$48.08 (\$40 of which was covered by my gas advance, leaving a remainder of \$8.08) and a receipt in the amount of \$8.80 from Staples in Charlottesville for the 75 Group Registration Forms we had copied during the December RSC. Together the two amounts come to \$16.88 which I've deducted from the \$40 gas advance I received for attending the AZF which was not needed as I rode with Kim to that event (leaving \$23.12). Bringing the total amount I am returning to the Treasurer today to \$331.12
- PR CONCERN IN THE APPALACHIAN AREA: Upon my return from MARLCNA I received a text message from our Regional PR Chair which stated "we have a problem in Lynchburg that needs to be addressed, traditions 6, 7, and 11". The text contained a link she had received to a news story about services being offered by a local community mission which included an "adult recovery program" in which they interviewed a local NA member who is employed by the mission, and a home group member of the meeting that is held at that facility. The segment included brief interviews with representatives of two other outside entities and identified the NA member by name. Not having an active PR Subcommittee in the Appalachian Area I asked our Regional PR Chair to contact the member and express the concerns regarding the Traditions which had been compromised. They spoke and the member in question was polite but adamant they had done nothing wrong. At the request of several other concerned members within our Area I contacted our Area Chair who had determined to attend this RSC and share the situation with the body in an effort to get suggestions, feedback, etc... Knowing the video would be shared and the situation discussed I extended an invitation to the member in question to come and participate. They stated

they didn't know if they would be available to attend but said "we are in the process of correcting what we can". I checked the website last night while writing this report and it appears the segment has been removed from that station's website. In addition, a controversial sign which included the Narcotics Anonymous logo along with the many other outside entities affiliated with the mission (and had been placed near the entrance of that facility) has since been removed.
