I first want extend my deepest apologies to the Gateway Area who were disappointed that Regional members were not onsite however the PR subcommittee showed up at the time of their committee was due to participate yet I did not have the information which lead to the members walking out of the subcommittee meeting. By the time this report is read this issue will be clarified moving forward. The Topics covered in the by the subcommittee was as follows: The Inmate Step Writing will be developed as a Task Force which will include Chair, Vice-Chair and Subcommittee Chairs to help with gaining participation and to include all Areas in this process that desire to help with supporting addicts that want to work steps while incarcerated. The Public Relations Subcommittee introduced a new number update # 540-277-9265 I will allow the PR Subcommittee to further expand on the options and how each Area will be able to manage their Area's inclusion of the helpline. We still have to work on the disposal of old out dated property. I have inherited this issue and would like to have input and information to aide in coming into a solution. This could possibly involve a change to policy yet, my concern is that this issue has been on the table for approximately a year. As your Vice-Chair and Policy Pro -temp to resolve this to prevent backlog and to ensure we have a system moving forward to aide with equipment being dead weight with no destination once it is outdated. I have nothing further I am grateful for the opportunity to be of service to the Region. In Loving Service, Antoinette B.

**Secretary report:** I have purchased stapler binder and a hole puncher; these things will better help me serve as secretary of the region. Thank you, Etta for your help with the minutes.

**Treasurer Report:** Good afternoon! As you will see in the report attached to the minutes, we started this reporting period with 12,722.43 in the bank; there was \$3710.87 in income and \$3675.40 in expenses, leaving us with a balance of 12757.90. We have \$1000.78 in uncleared checks, which puts us under our prudent reserve by \$2271.63. (I am not concerned about this because this past week I received a check from NDANA that had mismatched written and numeric amounts; if the check had been written out correctly, this would put us over prudent reserve, and we would have been making a donation to NAWS.)

The budgeted vs. actual report is attached to the minutes; for the fiscal year thus far we have spent \$18,702.86, which is \$10,853.95 less than we budgeted. Good job keeping expenses down!

I did some more research on ways to inexpensively provide the RD Team with debit cards. This is necessary before we consider any changes to policy. One method which would have cost the region nothing through our current bank did not pan out (the offering was not available in the state of Virginia), and all the other techniques I

researched cost several hundred dollars a year. I will continue to research this, but at this time I recommend we remove the debit card motion from policy because there is currently not a cost effective way to provide them to the RD Team.

To make accounting more easy for the treasurer, I'm be working with policy to introduce a motion that all requests for funds be accompanied by a funds request form This is a bit more complicated than just the form itself, as we have to separate monetary policy from Treasurer duties in policy. Receipts and/or a summary of projected expenses can be attached to this form, making auditing the books much simpler should the need arise.

## RD Report: December 21, 2019

The Planning committee has continued to meet to come up with Action Plans following the October Regional 2 day. David is going to present the Action Plans that we have come up with at some point during the meeting. I was unable to attend the Webinar on December 7 due to working. I have the notes from the drop box from NAWS.

The Central Atlantic Region is hosting the Autonomy Zonal Forum on January 25 th and 26th, 2020. NAWS world board members will be on site to facilitate the CAR/CAT workshops and NAWS update. We will begin at 10 am and continue to 5 pm. This meeting will be held at the Courtyard Marriott here in Charlottesville at 1201 West Main Street. There is a \$5.00 parking fee at the hotel. We will also be having a Zonal Panel meeting from 7 to 8 pm and a Comedian Improv Show will follow from 8:30 to 10 pm. ### DECEMBER 21, 2019

December 7, 2019 Conference Participant Webinar I was unable to attend this Webinar as I was on vacation and could not keep a signal to stay connected. ### H&I Report: H&I Subcommittee Meeting

November 16, 2019

The CARNA H&I subcommittee met on November 16, 2019 via Zoom. Those attending were Sherry V., Coleen C., Lee S., Antoinette B., and Nancy H. The meeting was opened with the Serenity Prayer.

I read the minutes from the last RSC meeting which was on October 20th. We discussed the Inmate Step Writing program (ISW) and the bi-weekly meeting of the group who were meeting by Microsoft Teams. There are about 3 or 4 people who regularly join in the meeting. Some of those concerns are the same things we have encountered throughout the time we have worked on this program such as: lack of volunteers to write to the inmates, lack of people to pick up service positions on the committee. One of the things we needed to establish a list of the facilities in each area that we are covering either by ISW or by trusted servants taking the meetings into the facilities. I hope to accomplish that today or at least start on it by asking the RCM's to provide me with a list of the facilities in their area as well as if they are being covered by H&I. If you as an RCM don't have that information, please take it back to your area H&I chair to get that information and bring it back to the RSC in February or email it to me on the car-na.org website. We talked about opening the meetings by using Zoom and talked about "renaming" the meeting as a task force. First and foremost, though we want to promote UNITY

in all aspects of the H&I subcommittee as well as getting the information obtained back to the H&I chair.

Because of the diligent work of Coleen C. and the other people who have worked on the ISW project since it began, we have made some changes and hopefully some baby steps forward. The ISW Task Force will be using the Zoom app for the meetings. Zoom is on the regional website and can be accessed easily. We have decided to meet on the first Saturday of the month from 9:30 – 10:30 am to eliminate any conflict with other regional meetings/events. That will make the first meeting January 4, 2020. However, there is a downside to this and that is John B. withdrawing from the ISW program due to his personal situation and journey in his recovery work. I told Coleen about the information gathering as far as the number of facilities being served in each area, that Lawrence E. did have a list or a partial list of them from his time serving as H&I chair. I'm not sure if he still has it or not.

The only matter of business for this body as H&I issue is the following: I received an email from Tom B. who serves on the H&I subcommittee of the Tidewater Area. He had a meeting with the warden of Sussex II prison in Waverly, VA. She was requesting H&I service for her prison. Tom made no promises to the institution regarding our ability to provide services there but is asking for some information/help in giving her an answer either way. I let him know about the meeting today but he has a conflict in his schedule and is unable to come. The question I need

an answer for first is what area covers Waverly VA? Just looking at the area map, it looks to be covered by the Outer Limits area. If someone could relay that information to me, I will be glad to take the next step(s) to give him an answer,

In closing, I had planned to attend the meeting today, but my children's father passed away unexpectedly last Friday from injuries sustained in a car accident and things are very chaotic still.
