Next were a presentation on Fellowship Development by Kris R. NZF FD Chair. Next were NAWS update by Sherry V RDA2 CARNA. Next were Autonomy Zonal Forum update by Merle S secretary AZF. Lastly were an update on US Zones by Dennis M Chair NEZF. The information that was presented were from the Regions request from the Planning results survey.

Conference Participant Webinar April 17, 2021 I attended this webinar yesterday as I had leave the GSR Assembly because they both fell on the same day. At this webinar the focus was on small groups discussion on how to gain the overall perspective. Two topics for discussion will be the type of information to collect. What are the things you would like to know? What are the questions that you think we should be asking and collecting information on regional or zonal level? How do we plan to collect this information? Is the region in good contact with the member Areas? Is the region meeting enough to gather that information hat way? Do you use a survey? Do you have any tips for other CP's? There were approximately 190 participants including interpreters, Naws staff, World Board members and XWB members who help take notes in the breakout rooms. Anthony gave an update on financials as well as literature sales and member contribution. Most expenses are under budget except legal expenses and in house production along with allocated expenses for accounting and technology. Literature sales are rising month to month but still nothing that we can use as data points for the 2nd year budget. (quoted by Anthony) Fellowship contribution is steadily rising. 750 members recurring contributions to date. The QR code has been fixed for contribution. Thomas Hall, PhD, is director of the Orange County Government Drug-Free Coalition. In this role, he oversees Orange County Government Prevention, Treatment, and Recovery initiatives and advises Mayor Jerry L. Deming's on relevant policy issues.

John Seeland's is currently the Chief Operating Officer at Crossroads of Southern Nevada, a treatment center accredited by The Joint Commission where every addicted human seeking recovery is accepted regardless of ability to pay.
