I attended the scheduled November subcommittee meeting 11-18-23 where a total of 3 to 5 members contributed to the discussions of the day we discussed correcting email addresses and forwarding addresses for the actual email address of record on our official reference material to avoid ghost boxes. Emails are still being filtered to remove any predated mail. Currently RD Team, carnadelegateteam.org and policy were some discussed that are in need of corrections. I learned from service members present about Ionos our web hosting company is currently configured to host several URLs and that CARNA is just one of them. Then other people wanted websites but with no webmaster available they made CARNA a multi-site serving peninsula, Blue Ridge, Appalachians, BRANA, Rappahannock all hosted out of that same site. SSL & domain are the only cost saves money; YAP phone line also runs on that site. Beach, Tidewater and Southside are currently the only standalone areas maintain their own web hosting. I met with the Truist Bank Manager Yolanda Johnson to apply for 3 debit cards as passed by our motion to give these to the Delegate Team for travel. Unfortunately, there have been changes Made to the cards and I elected not to apply for them as the treasurer cannot load a certain amount on the cards without them having full access to the entire treasury. I would be able to

lock the amount taken out per day but they would have full access and so I am bringing this to the body to report. There was another card that she said would have worked the way we had wanted but it was discontinued in September. The only other cards they have is a gift card and that will not work for some purchases that they will need. So, currently I have chosen not to go forward without your direction.

I spoke with Cathy Reiner at the VSIAs (Virginia Summer Institutes of Addiction) conference regarding getting our nonprofit rate back for the conference. She said that last year the board discontinued those rates, but she will request that they give the nonprofit rate again. She said that there is no guarantee that they will do such, but she will be in touch after the meeting. They met 12/15/2023. I am now waiting for her response.

I received 2 boxes of books by mail from the ECCNA for the regional distribution of basic texts to their H&I committees to give their area's jails and prisons. I have taken out 5 for Rappahannock and 5 for Almost Heaven as I can make sure that these are delivered and passed the rest back to the Vice Chair to distribute accordingly.


