April 2024 RSC Treasurer's Report Good afternoon,

I am beginning to compile all the paper receipts and documents from this term for hand off in June when my term ends, I am grateful for the experience and encourage others to serve outside of their natural talents as it promotes growth.

Currently we have a balance of \$20,630.18 with a Prudent reserve of 18, 149.25. We have an increase of Twillo charges where we are now getting billed 2x per month rather than once due to the addition of adding Tidewater. The Topics include:

Anyone in the room was allowed to ask questions, which is not the norm at professional events. I was able to I feel plant some seeds about health care person explaining about what our fellowship is about prior to release. FSS was able to offer the professionals 3 free CEUs for those attending the Professional's Day!

The person facilitating the meeting has been busy with an event but I hope to get it ironed out and actually see if its time saving.

I also attended two of the idts predatory and disruptive behavior. I had some challenges with one of the board members and later spoke with a woman that was cut off in my opinion and she

was quite upset about it too. This workshop can be a very sensitive workshop for some and needs to be carefully facilitated. I also attended Yap helpline programming. Many are still just learning about this.

I attended the banquet on Women in Service There was a ticket given to all and there were "prizes" Deb blue skies started the trend that instead of the person with a winning ticket just going and picking a gift that we took a newer member with us and let them pick and have the gift. Very inspiring to watch this dynamic, not plan, just unfolded. I was honored to be the speaker at this event.

I attended the Southeastern Zonal forum breakfast/business meeting. I didn't do breakfast, just the meeting. There was a lot of conversation from the facilitator. I was hoping to get minutes but their website is not very up to date. I attended the Sat Banquet and the World services town hall. There was not a lot of new information. The speaker was Jose Luis who has been a member of the world board for years. He was a wonderful speaker sharing his ESH.

On Sunday I attended the Florida Region Meeting. There is formal discussion of the Florida service symposium coming under the umbrella of the Southeastern Zonal forum like the Northeastern states service symposium NESSSNA did last years with the Northeast zone siting the FSS is more expensive with less attendance. Discussion on CEU's in Fellowship Development-Belinda as to whether are not offering them at the FSS Professional event could it be perceived as promotion. Also, a report was given on the banquet for Women in Service. PR person(Liz) is meeting with FD to coordinate a similar event. Also announced with the World services Pr webinar is being held. PR also offers learning days in Areas and mentoring or helping virtually members get ready for their interview with the Florida human resource panel. Reminding them their first responsibility is to start finding a replacement as soon as possible. I reported from the last symposium about the Florida RSO theft of funds. I asked if the money is being reimbursed. Quite a sore subject. If you recall over \$100,000.00 over an eight year period was stolen. The person was court ordered to pay back over time. Follow up of this reimbursement was not carried out and by the time this was realized the person had filed for Medicaid and apparently in Florida if one goes on Medicaid then they are not responsible for outstanding debts. So they only retrieved about \$20,000.00 dollars back. They were told they could go to court but were told they could spend \$40,000.00 to \$50,000.00 and still may not win. So they have decided at this point to move on.

The US collaboration of zones you heard about yesterday. I have been attending meetings and task groups. Emails from all over are coming in already. Helping help in our communication efforts. It's truly filling the service holes as was one of the goals.

I turned in my travel itinerary for Florida and was under budget and turn in my tentative expense itinerary for NESSSNA to the treasurer which is also under budget. Thanks for allowing me to serve.

RDA report – 226th RSC

The past two months have been filled with preparing for the GSR assembly, attending the Florida Service Symposium, and getting ready for the North Eastern State Service Symposium next week. Receipts from the Florida Service Symposium have been sent to the Treasurer and include: 360.94 for hotel, 510 for flight, 70, for registration, and 195 per diem for a total of 1135.94.

The March CP Webinar began with a NAWS report on the progress of the planning for the World Convention, reported on yesterday by Cindy at GSR assembly. The WB chair led a discussion on improving the World Service Conference and the process by which we deal with motions. We broke into small groups, some considering how to improve the conference and others focused on alternative ways to consider motions. My small group was focused on various ways to consider motions offline. There was little support for WB/HRP forming a workgroup to consider motions as the come in, primarly due to the issue of transparency. Consensus was formed in my small group around the idea of increasing the conference participant webinars to monthly and using that forum to take straw polls on motions as they come in. This would likely help many of the regional motion that fail due to the language that is used.

I am looking forward to the North Eastern States Service Symposium next week.

In response to the request of several members, I will be asking the Secretary to include my report on NAWS finances yesterday as an attachment to the minutes. Greetings CAR-NA family!

Lots of information has been given to your delegate team in the past couple of months! Great opportunities to network with other trusted servants in various positions in other regions at FSSSNA and we are looking forward to NESSNA this coming week. I have submitted receipts and been reimbursed for hotel/flight only for NESSNA, \$1128.07—under budget. As mentioned, we attended FSSNA in March. We split up as we could, but even those breakout sessions we attended together, we each got different take-aways. Our RD and I attended the Professionals Roundtable, which was very informative and gave a bit more insight into DRT/MAT and Medical Marijuana from a clinical aspect. My main takeaway and concern from that session was the professional/treatment views that 'forcing or mandating' people to identify as addicts is viewed harmful to the individual.

I attended several IDT workshops: Disruptive Behaviors, Reimagining and Revitalizing Service, DRT/MAT and as it Relates to NA and Gender Neutral Language. These workshops and sharing with other members/trusted servants have been extremely beneficial to myself personally and the delegate team. We see how best to facilitate these sessions, so we can better serve our areas when we hold similar sessions in our region/local areas. These are wonderful opportunities to share challenges, look at solutions and bring more awareness and understanding to these topics. For example, our group on Disruptive Behaviors addressed one behavior that was outside of the box, but happening in their area, who happens to have limited meetings. Members with time were sharing about staying clean without working 12 steps and discouraging newer member from starting that process- delivering a message of 'come hang out and you can stay clean'. Very good discussion and potential solutions were shared.

One of the things that stood out for me in the Revitalizing Service session, which we also facilitated yesterday at our GSR assembly, was looking at the possible shift from 'committees' to more project-based groups or task groups. This opens the service opportunities to more members, may be more attractive to be able to focus on specific projects that interest them, and takes away that aversion to commitment for longer periods of time, which often seems to be the hesitation in getting involved.

In the Revitalizing Service session, it was a common thread that we need to make service more attractive and get the younger, newer members involved. This was our topic yesterday in my breakout group during our GSR assembly. The lack of attendance for this was disheartening — one of the things we discussed was how to make these service events more fun, inclusive and attractive to more members. It is my hope going forward we can look at how we facilitate these events, even if it means reexamining policy and past practices. New ideas moving forward will only help our fellowship growth, development and participation.

We had a Town Hall with NAWS, with two WB members (Danny G and Jose Luis) and one staff member (Nick) in attendance. They also assisted in facilitating the IDT workshops throughout the weekend. There were some great questions surrounding BMLT, WCNA, follow up questions on some of the IDT topics.

I will finish up with updates on WCNA:

Approximately 12000 members have registered to date.

Checking the site this week- there are still 5 contracted WCNA hotels left with available rooms ranging from \$203-300ish. Waitlists are available at other hotels. Please do not call the hotels directly, there is a number to call for all housing questions and concerns on the WCNA page.

Deadlines to note:

- <u>Pre-registration</u> ends July 31. Cost increases to \$185 online and onsite after that date.
 PLEASE PRE-REGISTER! This helps plan for what we need, and what costs we can cut!
 PREREGISTERING will allow members to access merchandise on THURS. All others will not have access to the merchandise store until Friday.
- <u>No refunds or cancellations</u> after June 1. Transfers can be done by members by forwarding the bar/QR code received via email. Please be aware if you forward this, the recipient can add/subtract to the registration and or change the package, tickets, etc. Registrations will NOT be split up –so whoever has that QR code needs to pick up all of them at the same time.
- The deadline to buy <u>preconvention merchandise</u> is April 30. Preconvention merchandise will be picked up onsite. NO refund or exchanges after 4/30.

UPDATES:

Volunteer link/site will be available early May. We need about 2000 volunteers to make all of the magic work. You will be able to sign up for 2 hours or as many as you would like and request the area of service you would prefer. More details coming soon!

Preregistration will be available for pick up Tues and Weds at the DC Convention Center. Once the convention starts Thursday AM 8/29 – you will need a badge to enter the building. Registration sites will be at 2-3 nearby hotels (Marriott Marquis, Westin or Grand Hyatt).

There will not be a concert this year — probably due to cost/logistics. Saturday night will feature at Go-go Band/Party included in the cost of your registration. Go-go is a funk music genre that has its roots in DC. There are also 3 other coffee house music events, and 2 dances included in your registration.

Our workgroup will be conducting on site meetings with NAWS and WB in June, as well as a walkthrough of the facility.

As always, thank you for allowing me to be of service to our region! I look forward to meeting you all in person, visiting areas and getting to know you all better!


