Hi everyone

Great to be at our regional committee.

Yesterday was a great day, even though we had our share of hiccups. We hope that everyone will participate

in the upcoming Conference agenda report workshops and Conference approval track workshops. We hope to

do one at the AVCNA. We do have a timeslot there and will have had time to look at the CAR, but not time to

engage in conversations with others. But with only five motions, we should be able to help with making an

informed decision. We will also have some other discussions on issues coming up that we need your input and

perspective, so we can vote on our collective conscience

20251018 We had another CP (Conference participant) webinar yesterday. The beginning was so bittersweet,

and tears were shed. Anthony E stated that it would be his last financial report. Becky M. has signed a five-

year contract and will be our executive director of NA World Services. Anthony is staying on for a while as

Assistant Executive Director to help with the transition. I don't know how long Anthony has been our

Executive Director of World Service, but he was in the position in 2004 at my first conference. Anthony gave a

financial report and spoke on the reasons for the Jan 2026 15% price increase on virtually all literature items.

An overall increase in the cost of production was the biggest factor. On to the Conference Agenda Report. As

you heard yesterday, there are only five motions in the CAR. Two Regional Motions and three World Board

motions. The two regional motions were ones about using AI for translations instead of human translators,

and the other was to put book-length literature on inmate tablets. (Sounds good, but only 20% of

contributions contribute to over all budget) But it's only to do research at this time. The three world boards

were 1)approve updated The loner IP21 to IP#21, Staying clean in Isolation. 2)To approve the World Service

Strategic Plan (first time the plan has been a collaborative effort by all CPs. Also, the first time the plan is

being put before the conference for adoption. 3)New proposed guidelines for WCNA (World Convention of

Narcotics Anonymous): a. every 5 years beginning 2028, b. World Board selects location based on various

factors and c.) Revenue-neutral event. The next World Convention will be in Europe. Either Lisbon, Portugal,

Frankfurt, Germany, or Dublin, Ireland. The CAR survey will be posted online for all interested members and

delegates representing regional or zonal consciences. We will also be discussing at the conference the input

from the gender neutral language on how we talk about members and how we talk about the steps. A third

issue that will not be discussed at this time is how we talk about God. So Cindy and I will probably be including

this discussion in our CAR workshops. Question being given that we all want to provide a safe, welcoming,

inclusive Fellowship where everyone can recover (regardless of...) are we willing to explore these types of

changes in our literature to carry the message more effectively? If not, why? Next discussion question: Does

your group or area ask people if they're on MAT when they step up to celebrate or to serve? What do you do

next? And how can we foster unity and live with ambiguity, given our differences? How do we get past our

personal reservations and help newer members take root in our local communities? There will be an initial

straw poll of the five motions after April 18, and then we given info to have the votes ready by April 18 th . April

18 th is our GSR assembly. So we will be on a tight turnaround for our votes. The CAR survey and the discussion

questions will be on na.org/surveys, and the deadline for that is April 1. There have been revisions to some

board-approved material. The service pamphlet Group Business Meetings has been revised, adding a new

section on consensus and on delegation. As per guidelines, it will be posted for 90 days at a na.org/revising-

group-business-meetings. The review period for the draft of H&I basics: treatment section ended Friday, and

the hope is to have the third and final section, Committees, posted soon. The review period for the revisions

to Rural Service Basic just finished. It was just simple updates we were told. Your delegate team has access to

the videos from the Unity Day, and we can show them, but because the faces haven't been blurred, we are

asked not to distribute them in case someone posts them on social media. There was a discussion on an

update to a discussion board called Discourse. And last for the CP webinar is the regional report form that has

been updated. Your delegate team will be asking for all your H&I meetings to include in our regional report to

the conference. Please send them to us at the next regional meeting.

The delegates were urged to register for housing at the conference.

20251012 I attended the US Collaboration of Zones meeting. Representatives from all the zones in the

United States were in attendance. We had an update from each of the seven zones. If you would like to hear

more about the zones update, let me know. We then heard from the Communications Workgroup and, IT

Workgroup. The Public Relations workgroup has established a consistent meeting time. I attended the last

one. We are close to doing our first eblast to appropriate organizations, reaching out to them on Na's behalf.

Two task groups were prioritized from strategic planning. Mentorship/Training/Consistency task team. The

second task group is the Rural and Marginalized Communities Project. We need your input on a survey we

created. The survey focused on groups, areas, regions, and zones to identify these areas. The two task groups

are working together on this project.

Greetings CAR-NA family!

Today I will be reporting to you on two key events I have participated in since our last RSC: Unity Day and our CP (Conference Participant) Webinar on August 16, 2025. Unity Day was a success!! In case you missed this, NAWS facilitated a 24-hour Unity Day celebration via Zoom Sept 5-6. The event was comprised of time slots with diverse content, hosted by zones from around the world, our WB and NAWS, covering more information about the zones from all over, a few Issue Discussion Topics and other information pertinent to our fellowship as a whole. There was a 50+ year member panel, an International Panel and a special panel on Creating our Future: Women and Youth. This was done in a webinar format; however, the chat was enabled for most of the event; it was awesome to see our fellow addicts from around the world checking in, offering NA love and greetings.

Our zone, the NEZF, had a 50-minute slot, scheduled at 6/630 am on Saturday morning

ET. I was honored to facilitate the task group responsible for the planning and presentation for our Zone. This was done as a part of our NEZF Fellowship Development committee.

We presented our zone via a video representation of what we do, how we do it, and our regions served. We then had 3 speakers from our zone share their experience, strength and hope around one of their favorite Unity quotes from our literature. They focused on how unity in service and being of service in general has enriched their recovery and lives in general. We finished with two of our long-term NEZF members presenting a history of the NEZF. It was an amazing experience to be a part of, as well as watch.

Our last CP (Conference Participant) meeting was August 16, 2025; Attended by 105 Regional Delegates, 83 Alternate Delegates, 5 Zonal Delegates, 13 World Board members, 3 Human Resource Panel members, 2 Co facilitators, 21 NAWS staff, 10 former world trusted servants (to lead small groups) and 7 interpreters. That's A LOT of people (about 250!).

This CP Webinar was focused on the Strategic Plan we have developed in the 2023-26 conference cycle, which began at our iWSC (Interim WSC) in 2025. We spent most of the two hour sessions reviewing the draft solutions in small groups.

The 2026-2029 Strategic Plan has four pillars or broad areas where we focus our service efforts: Public Relations, Service System Support, Fellowship Support and World Service System and Operations. Through the collaboration process, we collectively decided what issues under each 'pillar' were most important to address. Each issue has one objective (WHAT we want to accomplish) and solutions (HOW we

intend to accomplish). This is the first time that we have collectively put together a strategic plan, and the last time the CPs would discuss these prior to being included in the CAR (Conference Agenda Report).

Strategic plans are not linear: it's an ongoing process always in motion. We continue to look at and think about what comes next as we wrap up the 2026 plans at the upcoming conference.

Each participant has a role in fulfilling our NA Vision. NA now speaks more than 100 languages, and we are now in 143 countries. World Services is the only place that blends all of these diverse perspectives. We are able to hear from the Fellowship as a whole and produce material that reflects our ever-growing diversity. Zones and regions have an important, active role, gathering ideas on the front end that help shape the projects, workshops, and reviewing literature drafts—this essential work happens at the zones and regions.

It is very important that our areas and our region get involved and continue to offer ideas, input and participate in this process, so your delegate team can continue to carry the needs, ideas and solutions of our region/areas forward and be a part of this process.

We talked about the CAR Survey, which helps prioritize needs for recovery literature, Issue Discussion Topics and service material. This is the first time the CPs have collaborated with the WB and NAWS to co-create the CAR Survey. More than 500 ideas were collected, compiled and then prioritized. Ideas with more than 25% delegate support will be included in the CAR Survey, which is still a lot of ideas!

The Public Relations issue discussions centered around the 'Credibility of NA' and looked at raising fellowship awareness and about the importance of effective PR efforts

in carrying out our message and fellowship development. The solutions we looked at were to create an internal NA service campaign focused on PR and development of more PR training and tools to support member engagement.

The Service Systems Support issue discussion centered on a few topics.

- The rise of virtual NA meetings, with challenges in the ability for these groups to participate in the service structure and have their voices heard. Solutions include best practices for virtual NA groups and areas that can connect them to NA services.
- ② Development and organization of trusted servants: understanding the complimentary roles, committees in the Vision for NA Service by creating a contemporary guide to service, replacing the Guide to Local Services (GTLS).
- Mentorship of our trusted servants by inspiring members to get involved, creating tools and messaging, encouraging younger members (age and clean time) to be of service.
- ② Disruption of the flow of funds. These solutions include resources on setting up electronic contributions, and materials or messaging on the importance of our contributions and seventh tradition.

Fellowship Support discussion focused on:

- ② Safety and belonging -- raising the level of awareness about inclusiveness in our diverse fellowship and developing tools, revising literature (as in the Group IP or booklet) that may help members feel safe, welcome and supported. This includes gender specific language and predatory/disruptive behavior.
